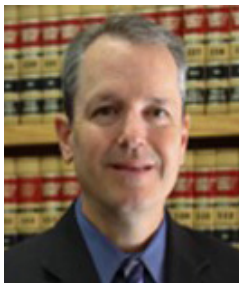


## Cal/OSHA Update: What to Watch for in 2023
